SC CARTS ELECTRIC VEHICLE LIMITED WARRANTY  
(ONLY APPLICABLE IN NORTH AMERICA)

SC Carts hereby warrants all parts of your new NXT electric vehicle, which was purchased or leased from SC Carts or an authorized SC Carts dealer and which is normally operated in North America, subject to the exclusions described below.

**1. WARRANTY:**

The warranty period begins on the date the NXT electric vehicle is delivered to you from SC Carts or an authorized SC Carts dealer. The warranty coverage and periods are as follows:

**BASIC COVERAGE:**

- The basic warranty coverage period is 24 months or 10,000 kilometers, whichever comes first.
- This warranty covers any repairs needed to correct defects in material or workmanship of all parts and components of your new NXT electric vehicle, except for those excluded below. If the part is covered by one of the separate coverages described below, that specific coverage applies instead of the basic coverage.

**FRAME COVERAGE:**

- The frame warranty coverage period is 60 months or 15,000 kilometers, whichever comes first.
- This warranty covers any repairs needed to correct defects in material or workmanship in the frame of your new NXT electric vehicle, except for those excluded below.

**ORIGINAL EQUIPMENT BATTERY COVERAGE:**

- The original equipment battery warranty coverage:  
Lithium: 36 months or 2000 cycles recorded by Battery Management System, whichever comes first, with minimum 80% retention of battery capacity over the warranty period.  
Note: replacement batteries are covered under the NXT electric vehicle Parts & Accessories Limited Warranty.
- This warranty covers any repairs needed to correct defects in material or workmanship of the original equipment battery installed in your NXT electric vehicle, except for those excluded below.

During the warranty periods described above, SC Carts will, free of charge, repair or replace, at SC Carts exclusive option, any part determined by SC Carts to be defective - subject to the restrictions and exclusions contained in this warranty document.

If SC Carts elects to repair or replace a defective part, SC Carts may, at its discretion, provide a factory reconditioned part or a new part from an alternate supplier. All parts used in repairs under this warranty will themselves be warranted for the remainder of the applicable warranty period counting from the first delivery of the NXT electric vehicle. All parts replaced under this warranty immediately become the property of SC Carts.

## 2. GENERAL EXCLUSIONS:

### THIS WARRANTY DOES NOT COVER CLAIMS OF DEFECTIVE DESIGN

Excluded from this warranty shall be any failures caused by:

- (a) Modifications, alterations, or changes that affect NXT electric vehicle weight distribution, stability, performance, condition or operation or which alter the output of the car's battery charger.
- (b) Installation of any parts or accessories that are not SC Carts original equipment or are not approved by SC Carts in advance of installation.
- (c) Damages resulting from an accident or collision.
- (d) Abuse or neglect of the vehicle or any included or related component, or use that is contrary to the uses, precautions and specifications set forth in the User's Manual.
- (e) Failure to carry out routines and maintenance as set forth in the User's Manual, including but not limited to charging schedules, failure to tighten battery terminals, proper tire inflation and checking wheel alignment.
- (f) Damage due to improper storage or transportation.
- (g) Acts of nature, or vandalism, or other such events that are unrelated to the manufacturing or maintenance of the vehicle.

Additionally, this warranty does not cover the repair of any SC Carts vehicle in which the battery, odometer, motor controller/inverter or on-board computer unit has been altered, repaired or replaced, and the actual mileage or ampere hours of the battery cannot be correctly and readily determined

## 3. SPECIFIC ITEM EXCLUSIONS:

In no event will this warranty cover any of the following:

- (a) Adjustments or repairs made due to normal wear and tear after the first 90 days of the warranty period.
- (b) Routine maintenance items set forth in the User's Manual.
- (c) Cosmetic deterioration due to exposure or normal wear and tear.
- (d) Electrical components that are susceptible to fluctuations in current and voltage.
- (e) Tires.
- (f) Costs incurred by you in connection with the transportation of the vehicle to SC Carts or to an appointed SC Carts dealer.
- (g) Costs incurred for shipping or transportation and all associated shipping costs of parts to be warranted to SC Carts, SC Carts appointed dealer, or to the customer.
- (h) Loss of vehicle use, lost time, inconvenience.

## 4. WARRANTY TERMINATION:

If SC Carts, in good faith and after reasonable investigation, determines that the information submitted in connection with a claim under this warranty is false or intentionally misleading, this warranty shall immediately terminate and all pending repairs or replacements hereunder shall be at your sole cost and expense.

## 5. CUSTOMER RESPONSIBILITIES:

In order to receive the benefits of this warranty, you must:

- (a) Provide proof of the date of delivery of the NXT electric vehicle either by (i) completing the warranty registration form at the time of the delivery or (ii) providing a copy of the original sales invoice;
- (b) Provide notice of any warranty claim directly to SC Carts within 14 days after discovery of the defect giving rise to such claim; and
- (c) Promptly present the vehicle for repair, during regular business hours, at SC Carts or an authorized dealer or distributor appointed by SC Carts.

## 6. TRANSFERABILITY:

To transfer any remaining warranty from the original purchaser to any subsequent purchaser, the subsequent purchaser must present the vehicle for inspection and warranty registration at SC Carts or a dealer appointed by SC Carts within 10 days after the transfer of ownership. SC Carts or the appointed SC Carts dealer may charge a reasonable service and registration fee.

## 7. DISCLAIMER, LEGAL RIGHTS:

SC Carts makes this warranty in lieu of all other warranties, expressed or implied. All implied warranties, including those for merchantability and fitness for a particular purpose WHICH EXCEED THE DURATION OF THIS WRITTEN WARRANTY are hereby expressly disclaimed by SC Carts and excluded from the scope of this warranty. SC Carts further disclaims and excludes from this warranty all liability for incidental, consequential, REMOTE AND SPECIAL damages, including but not limited to damages for loss of use, to the maximum extent permitted by applicable law. Some states do not allow the exclusion or limitation of incidental or consequential damages or limitations on how long an implied warranty lasts, so the above limitations or exclusions may not apply to you. This warranty gives you specific legal rights, and you may also have other rights which vary from state to state.

If SC Carts elects to repair or replace a defective part, SC Carts may, at its discretion, provide a factory reconditioned part or a new part from an alternate supplier. All parts used in repairs under this warranty will themselves be warranted for the remainder of the applicable warranty period counting from the first delivery of the NXT electric vehicle. Prior to any warranty replacement parts being sent out to our customer or dealer the defective parts must either be returned for inspection or the customer or dealer must pay for the part and a credit will be issued once the defective part is returned and inspected. All parts replaced under this warranty immediately become the property of SC Carts.
